



# Canton Festival of the Arts Application - FOOD

**DESCRIPTION:** An Art and fine craft festival featuring local and regional artists. The festival also offers activities for children, the serenity garden, live entertainment and a food court.

**TIMES & DATES:** May 4 & 5, 2019, 10:00 – 5:00 p.m., Saturday and Sunday

**LOCATION:** Brown Park in historic downtown Canton Georgia. The City of Canton is the county seat for Cherokee County which has earned the title of one of the fastest-growing counties in the Atlanta region. It is located 40 minutes north of Atlanta and 30 minutes south of the Blue Ridge Mountains

**PHOTO:** One photo of the booth or truck.

**BOOTH:** The size is either 10X10, 10X20 and will vary for food trucks. Vendors must furnish their own tent, equipment and meet the health department rules & regulations. Health Department required prior to set up.

## **VENDOR FEES:**

Single-space 10X10: \$200.00  
Double-space 10X20: \$400.00  
Food truck: \$400.00

**ACCEPTANCE PROCESS:** Applications will be review and acceptance will be based on food offered and display. The festival will limit the type of food sold so duplicates are limited. Beverages may not be sold as the festival will sell sodas, water and beer/wine. Application deadline: April 5, 2019. Acceptance notices: April 12, 2019.

**HEALTH DEPARTMENT:** It is the vendor's responsibility to submit your request to participate in the festival to the Health Department and follow all rules and policies. You must submit your food certificate to the festival coordinator by April 19, 2019.

**POWER:** Power is available but is limited. Note your power needs on the application and the equipment to be used. Actual cooking and grills are not permitted.

**SET UP:** Friday, May 3, 1:00 p.m. to 6:00 p.m. and Saturday, May 4, 6:00 a.m. – 9:00 a.m. Must be set up by 9:00 a.m. on May 4<sup>th</sup> for the Health Department inspection. Booth must have some kind of protective covering on the ground.

**PARKING:** Parking is available and all participants must park in the designated parking area. Vehicles are NOT permitted in the festival area during festival hours. Failure to comply could result in removal from the show and future shows. ALL VEHICLES MUST BE REMOVED FROM THE FESTIVAL AREA 30 minutes before the festival begins

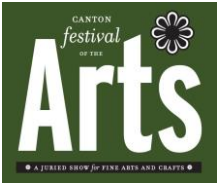
**TEAR DOWN:** Teardown may begin at 5:00 p.m.; however, vehicles are NOT permitted in the load-in zone until the booth space has been completely packed up. All booth spaces must be packed up by 7:00 p.m. on Sunday.

**TAXES:** The exhibitor is responsible for collecting and paying all Georgia sales tax and any additional applicable city, county and federal taxes. Sales tax in Cherokee County is 6%.

**NO REFUNDS:** The show is a rain or shine event. No refunds will be given for the cancellation of the event due to inclement weather or circumstances beyond our control or due to a denial by the health department.
